1. TITLE

1.1 This policy shall be called the 'Policy for determining Material Subsidiaries' ("Policy").

2. INTRODUCTION

- 2.1 The Board of Directors ("Board") of Paras Defence and Space Technologies Limited ("Company") has adopted the following policy and procedures with regard to determination of "Material Subsidiaries" in order to comply with the requirements of Regulation 16(1)(c) and Regulation 24 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "SEBI Listing Regulations").
- 2.2 The Policy shall come in to force with effect from the date of listing of the equity shares of face value of ₹10 each of the Company on BSE Limited and National Stock Exchange of India Limited. (collectively referred to as the "Stock Exchanges").

3. **DEFINITIONS**

- **3.1** "Audit Committee" means the committee formed under Section 177 of the Companies Act and Regulation 18 of the Listing Regulations by the Board of the Company, from time to time.
- **3.2** "Companies Act" means the Companies Act, 2013 read with the rules thereunder, as amended.
- **3.3** "Independent Director" means an independent director as defined in Section 2(47) and Section 149(6) of the Companies Act.
- **3.4** "Material Subsidiary" means a Subsidiary whose income or net worth exceeds 10% of the consolidated income or net worth respectively, of the listed entity and its subsidiaries in the immediately preceding accounting year.
- **3.5** "Material Unlisted Indian Subsidiary" shall mean an unlisted subsidiary, incorporated in India, whose income or net worth (i.e. paid up capital and free reserves) exceeds 10% of the consolidated income or net worth respectively, of the Company and its subsidiaries in the immediately preceding accounting year.
- 3.6 "Significant Transaction or Arrangement", as per Explanation to Regulation 24(4) of the SEBI Listing Regulations, shall mean any individual transaction or arrangement that exceeds or is likely to exceed 10% of the total revenues or total expenses or total assets or total liabilities, as the case may be, of the unlisted Subsidiary for the immediately preceding accounting year.
- **3.7** "**Subsidiary**" shall be a subsidiary of the Company, as defined under Section 2(87) of the Companies Act.
- **3.8** "Unlisted Subsidiary" means subsidiary whose securities are not listed on any recognized Stock Exchanges.

4. POLICY

- 4.1 an unlisted Indian Material Subsidiary of the Company would be identified, if any, as one time exercise and such exercise shall be done during each financial year and the conclusion placed before the Audit Committee of the Company and the Board.
- 4.2 At least 1 (one) Independent Director of the Company shall be a director on the Board of the unlisted Material Subsidiary, whether incorporated in India or not. Material Subsidiary, for the purpose of this clause, means a subsidiary whose income or net worth exceeds twenty percent of the consolidated income or net worth respectively, of the Company and its Subsidiaries in the immediately preceding accounting year.
- **4.3** The Audit Committee of the Company shall review the financial statements, in particular, the investments made by the unlisted Subsidiary on an annual basis.
- **4.4** The minutes of the Board meetings of the unlisted Subsidiary shall be placed before the Board of the Company.
- 4.5 The management shall periodically bring to the notice of the Board of the Company, a statement of all Significant Transactions and Arrangements entered into by an unlisted Material Subsidiary.
- 4.6 The management shall present to the Audit Committee annually the list of such Subsidiaries together with the details of the materiality defined herein. The Audit Committee shall review the same and make suitable recommendations to the Board including recommendation for appointment of Independent Director in the unlisted Material Subsidiary.
- **4.7** Every listed entity and its material unlisted subsidiaries incorporated in India shall undertake secretarial audit and shall annex a secretarial audit report given by a company secretary in practice, in such form as specified, with the annual report of the listed entity.

5. DISPOSAL OF MATERIAL SUBSIDIARY

- **5.1** The Company, without the prior approval of the members of the Company by special resolution, shall not:
 - dispose of shares in its Material Subsidiary which would reduce its shareholding (either on its own or together with other Subsidiaries) to less than 50% or cease the exercise of control over the Material Subsidiary without passing a special resolution in its general meeting except in cases where such disinvestment is made under a scheme of arrangement duly approved by a court/tribunal or under a resolution plan duly approved under Section 31 of the Insolvency and Bankruptcy Code, 2016 and such an event is disclosed to the recognized stock exchanges within one day of the resolution plan being approved; or
 - (b) sell, dispose and lease of assets amounting to more than 20% of the assets of the Material Subsidiary on an aggregate basis during a financial year without the prior approval of the shareholders by way of passing special resolution in its general meeting, unless the sale/disposal/lease is made under a scheme of

arrangement duly approved by court/tribunal or under a resolution plan duly approved under Section 31 of the Insolvency and Bankruptcy Code, 2016 and such an event is disclosed to the recognized stock exchanges within one day of the resolution plan being approved.

6. DISCLOSURES

6.1 This Policy shall be disclosed on the Company's website and a web link thereto shall be provided in the annual report of the Company.

7. REVIEW OF THE POLICY

- 7.1 The Audit Committee may monitor and review the Policy and recommend the necessary changes to the Board for its approval.
- 7.2 The Audit Committee shall review Policy for determining Material Subsidiaries atleast once in every three years.

8. AMENDMENT

- 8.1 This Policy may be amended, modified or supplemented from time to time to ensure compliance with any modification, amendment or supplementation to the Listing Regulations or as may be otherwise prescribed by the Audit Committee or Board from time to time.
- 8.2 The Policy shall be effective from the date of listing of the equity shares of the Company on the Stock Exchange(s). Any subsequent amendments, modification or supplementation to this Policy shall be effective from the date of approval of Board, unless specified otherwise.
